2. Basis of the Charge (<i>set forth a clear and concise statement of the facts constituting the alleged unfair labor practices</i>) 1) Charging Party is employed by Boeing at a work site in North Charleston, SC that formerly had IAM representation. 2) In September 2009, Charging Party and his co-workers exercised their protected rights under federal labor law and decertified the IAM from their Boeing facility, by a vote of 199 to 68. (NLRB Case No. 11-RD-723). Charging Party was the Petitioner in that decertification election. 3) On March 26, 2010, in retaliation for this decertification and for these Boeing employees' exercise of their protected rights to reject IAM representation, the IAM unions filed an unfair labor practice charge against Boeing (Case No. 19-CA-32431) over its decision to open a new aircraft assembly line in North Charleston, SC. Charging Party and fellow employees learned of the IAM unions' unfair labor practice for the first time in April 2011 when it was publicly reported that a complaint was issued by the NLRB's Acting General Counsel. 4) By that and related acts, the IAM unions are attempting to sabotage the jobs and work of the employees in North Charleston, SC, for the sole or primary reason that these employees rejected IAM representation and chose to work for Boeing without the interference of a labor organization. The union's animus against South Carolina Boeing employees who decertified it and who have chosen to work in a non-union setting (as is their Section 7 right) is made clear by public statements of IAM officials, principally Lodge 751 official Tom Wroblewski. 5) The above-described acts constitute a violation of the NLRA and the duty of fair representation, and threaten, restrain, retaliate, coerce and discriminate against all of the Boeing employees in North Charleston, SC in the exercise of their section 7 rights to refrain from collective activity.
